2019/568 CHAIRMAN'S ANNOUCEMENTS

The Chairman asked Councillors to note that the Civic Service will be held on Sunday 6th October 2019 at St Wilfrid's Church on Main Street. Councillors were also asked to note the St Wilfrid's Church 140th Festival which runs from Friday 11th October 2019 until Sunday 13th October 2019.

The Chairman reported that Nick Hunt from Leeds City Council has agreed to alter the new road signs to read 'Welcome to the Hamlet of Old Pool Bank'. The Clerk will confirm this in an email to Mr Hunt.

2019/569 PUBLIC PARTICIPATION

Mr Shears addressed the meeting about the ongoing problem of a very large overgrown tree outside his and other properties at Churchill Flats. He thanked Ward Councillor Anderson and Councillor Barlow for attending a meeting earlier in the day. After some discussion it was agreed that the clerk will contact various utility services to ask inspections of the area be undertaken to assess any damage caused by the roots of this tree and others around its base. Further discussions with the Housing Office will continue to try and get a resolution to the problem.

Another problem close to number 9 Churchill Flats is also being investigated.

Councillor Rowling reported that plans for the compulsory consultation on the Neighbourhood Plan had begun and will run from the 6th September 2019 and the 18th October 2019. Details of the Drop-In sessions were provided to councillors.

Councillor Davey updated council on the work planned to renovate notice boards on the Swallow Estate and Main Street. Councillors noted and approved the quotes Councillor Davey had received.

2019/576 **TELEPHONE BOX**

The clerk and Councillor Parker updated the meeting on progress of the Planning Application and possible logistical problems in moving the telephone box to its new site. After some discussion it was agreed to continue towards moving the box to Stocks Hill. Advice will be sought from Richard Holdsworth at Leeds City Council on moving the telephone box and advice on the possible traffic disruption from Leeds Highways Department.

2019/577 PARISH COUNCIL LAND ADJOINING LAND OWNED BY THE RGMC

Councillor Parker asked councillors to note the report they had received from Ailsa Bearpark which spelt out the problems concerning security of the land in question.
