Minutes of the last meeting, 25th March 2019, approved.

Actions arising: no response from John Ryan to Alexa's email of 19th March requesting changes to the website. The website is still as it was at the last meeting. Jo Rowling to talk to John Ryan at Parish Council Finance Committee, 30th April. Barbara then to follow this up at Parish Council on 13th May. Since the Statutory Consultation cannot proceed until the website is in order it is a priority to get this sorted. Potential solutions to be pursued: if John cannot do this within his allocated hours, perhaps overtime payment or paying someone else to do the work might be needed. Jo and Alexa are prepared to assist if necessary.

Updates: Ian Mackay has promised the EU Screening results and Neighbourhood Plan Map for 10th May. On the basis of this, together with the Parish Council meeting of 13th May, the next Neighbourhood Planning meeting is scheduled for 20th May.

Business, working on the Pre-consultation Draft Plan: the PID results grid had had different wording relating to 'Land East of Main Street' from that in the Draft Plan. The PID wording has now been changed to match the wording in the Plan.

Other aspects of the Plan were tidied up and clarified but there was a question about the Leeds Site Allocations Plan in relation to the PAS land off Old Pool Bank (Draft Plan p. 39 – 23.1 Hectares, 540 homes). Jo will check the number of hectares remaining since the latest revision of the SAP, and the proposed number of houses. **Now done** – see screen capture below from page 44 of Leeds Site Allocations Plan, Leeds Local Plan, Proposed Main Modifications to the Leeds Submission Draft Site Allocations Plan, May 2017. **Total now proposed - 11.07 Hectares, 260 houses.**
